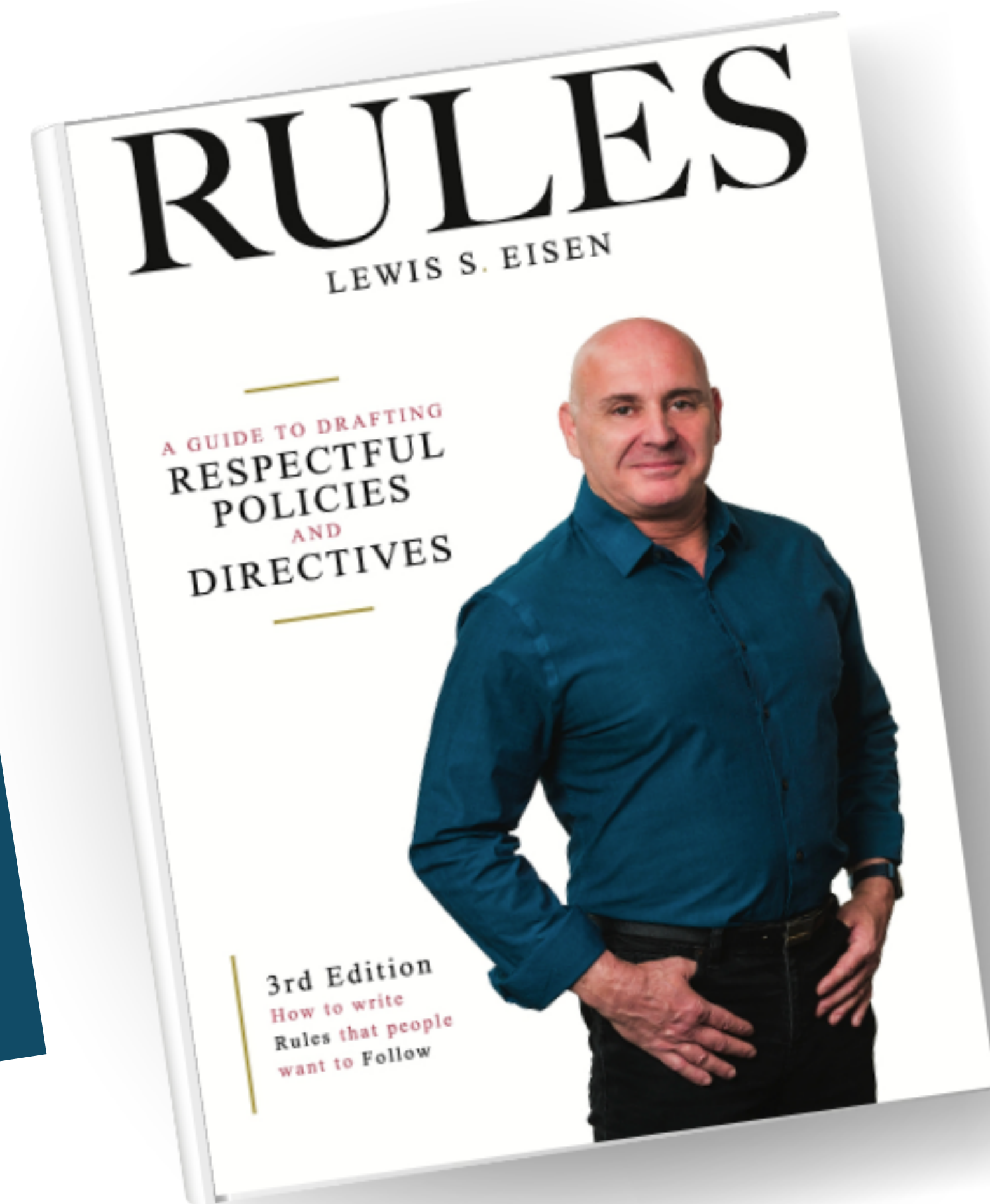



Social Media Policy

It is prohibited for any  employee to use or manage a social media account that is not approved by the Associate Deputy Minister.

Using the Fishing and Wildlife Management Information System

...the redistribution of raw data is prohibited.

The specific locations of secured records are not to be published in any form without the express written consent of Fish and Wildlife.

Criminal Code

§235 (1) Every one who commits first degree murder or second degree murder is guilty of an indictable offence and shall be sentenced to imprisonment for life.

§344 (1) Every person who commits robbery is guilty of an indictable offence and liable

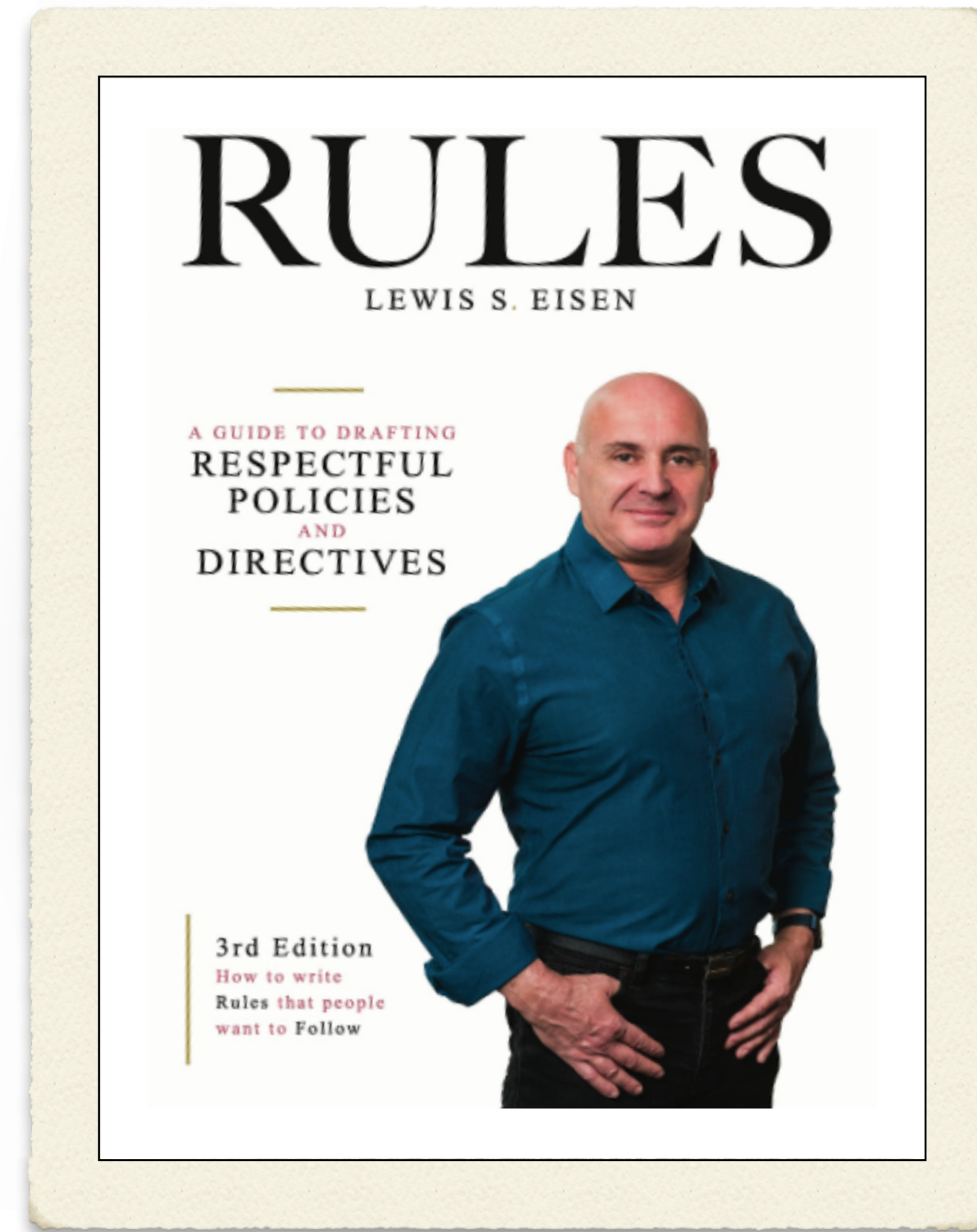
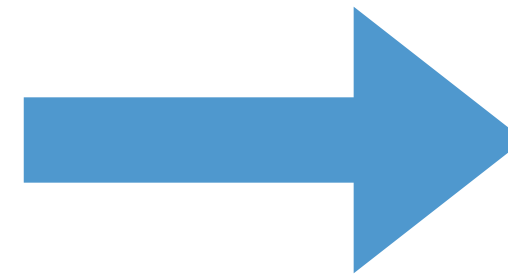
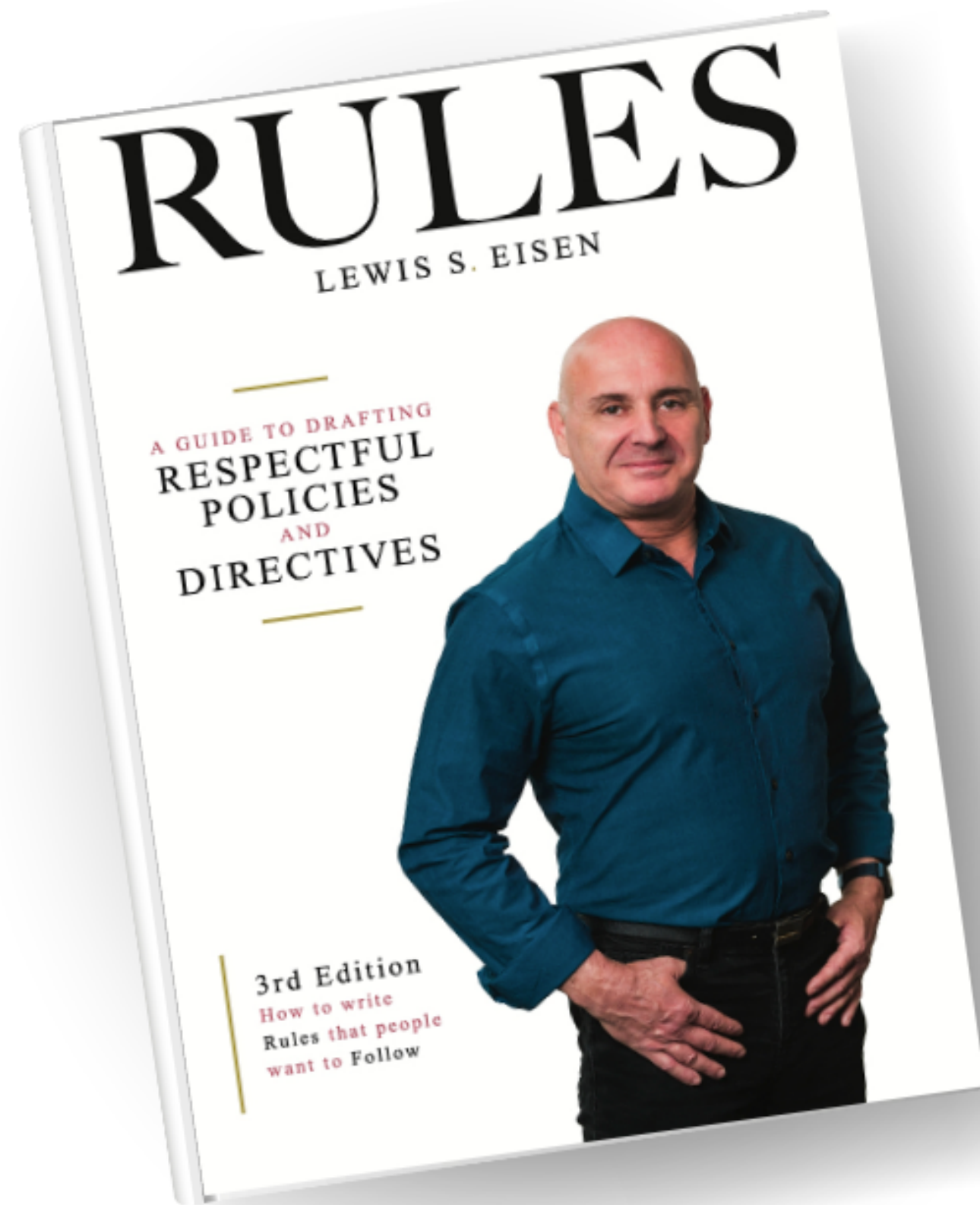
(a) ...to imprisonment for life and to a minimum punishment of imprisonment for a term of

(i) in the case of a first offence, five years, and

(ii) in the case of a second or subsequent offence, seven years

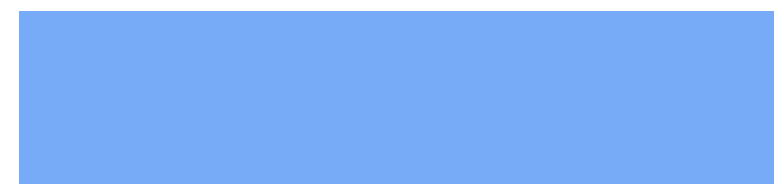

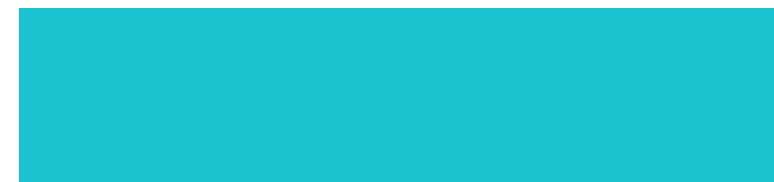

Policy on Acceptable Colours

3. When choosing colours for e-books, we conform to W3C recommendations for maintaining a readable contrast ratio between text and background colours.

Technical Explanation

Use the following formula to determine whether a highlight colour is compliant with the policy.

$$Y = (0.2126 * \mathbf{R}) + (0.7152 * \mathbf{G}) + (0.0722 * \mathbf{B}).$$

Acceptable values of Y range from 102 to 153.

Here are some examples of colours you can use:
